# Pikes Peak Hospitality Grant Modification Request

- ▶ Approved for a modification to include adults in the training in March 2012.
- ▶ Requesting another modification to return this grant to its original intent: serving youth.
- ▶ School district has developed a new program for Culinary/Hospitality for the 2012–2013 Academic Year, allowing Pikes Peak Workforce Center to partner in providing opportunities for high school students pursuing careers in this industry.
- ▶ Increased participant numbers from 30 to 40 students and the majority of the funding will go towards providing work experience for the students.
