Vehicle Daily Rental Fee Return

General Instructions

Who Must File

If you rent motor vehicles for less than 30 days, you must collect and remit \$2.00 for each rental per day. Motor vehicle means vehicles designed for travel on public highways and used to transport people or property. This includes motorcycles, motor scooters, cars, trucks, neighborhood electric vehicles, trailers, and recreational vehicles (RVs), but does not include motorized bicycles.

Note: Rentals made to the federal government for official use are not subject to this fee.

When to File

Returns are filed on a monthly basis and must be postmarked the 20th day of the month, following each reporting period. A return must be filed even if no tax is due.

Filing an Amended Return?

If you are filing an amended return, check the amended return box. A separate amended return must be filed for each period. The amended return must show all lines as corrected, not merely the difference(s). The amended return replaces the original in its entirety.

For additional Motor Vehicle Daily Rental Fee information, refer to FYI General 19.

Specific Instructions

- Line 1 Vehicle Days Rented**—Enter the number of daily rentals. If a vehicle is rented twice in the same day, each customer is charged the fee.
- Line 2 Exempt Vehicle Days**—Enter the number of daily rentals that are exempt.
- Line 3 Number of Vehicle Days**—Subtract line 2 from line 1.
- Line 4 Tax**—Multiply line 3 by \$2.00.
- Line 5 Amount Owed**—Enter total from line 4. This is the amount due with your return.

Payment Information

Send a separate check with each return submitted. Include the account number on your check to ensure proper credit.
