Military License Plate Application

C.R.S. 42-3-213 & 42-3-218(3)

Military license plates may be issued to a truck that does not exceed sixteen thousand pounds empty weight, a passenger vehicle, a motorcycle, or a non-commercial or recreational vehicle unless otherwise specified. Military license plates are issued through the print on demand process, after meeting the required qualification and payment of applicable taxes and fees the license plate will be mailed to your mailing address on your motor vehicle record. Applicant must complete all sections. Failure to complete all sections will result in the application being returned and delay the issuance of the selected license plates.
