

**PERMANENT PARTIAL DISABILITY BENEFITS FOR SCHEDULED INJURIES, C.R.S. § 8-42-107(2)**

**Formula: Percentage of Impairment (rating) x Number of Weeks x Rate (based on date of injury )**
