Dear Madam and Sir:

We submit this report on the state's capital leases as required by CRS 24-30-201(1)(l). At June 30, 2015 the state had \$238.2 million of gross assets under lease, which is the original fair value of the assets without regard to depreciation. This compares with \$344.2 million at June 30, 2014. Future minimum payments at June 30, 2015 for existing leases were:

property based on a state contract. The state entered the capital leases summarized on the attached schedule during Fiscal Year 2014-15 or in earlier years. The amounts shown do not include lease purchase agreements funded by Certificates of Participation (COPs).

The schedule was compiled from information prepared by state agencies and submitted to our office for preparation of the state's Basic Financial Statements. Although this schedule is not audited, the State Auditor will audit the information from which it is prepared as part of forming an opinion on the state's financial statements.
