

Rule 14 Electronic Promotional Credit Reporting

Reported Tax Revenue Paid must increase at least 3.5 percent, compounded annually, to determine tax rate adjustment eligibility. FY 2019 Tax Revenue Paid decreased 0.22 percent from the FY 2018 (Base Year). Since the criteria to determine tax rate adjustment eligibility was not met, the Colorado Limited Gaming Control Commission could not authorize any tax rate adjustments.
