IN-DISTRICT **MEMBERSHIP “ACTIVATION” ELIGIBILITY**

People who reside within the Garfield County Parachute/Battlement Mesa Park and Recreation taxing district will—with certain documentation be eligible for in-district membership rates for GVRC. Dependents of eligible parents or guardians will also be eligible for in-district membership. Most eligibility can be determined immediate, but could take up to 5 business days.

IDENTIFICATION VERIFICATION

(One Photo ID Document will be required.)

- Driver’s License (Valid)
- Colorado State ID Card (Valid)
- Government Issued ID Card
- Student ID Card
- Passport
- Permanent Resident (Green) Card

ADDRESS VERIFICATION—

One of the following documents is required. The document must be original. The Physical Address must be printed on the form PO Boxes will NOT be accepted.

- Current Utility, Telephone or Medical Bill
- Pay stub with physical address (within 45 days)
- Major Credit Card or bank Statement with physical address (within 45 days)
- Court issued document with physical address
- Mortgage paperwork, lease or rent receipt or property deed showing address
- Current Lease—all residents must be listed on lease
- Major Department Store i.e. Kohl’s Sears,
- Target, Walmart (within 45 days)
- Current Homeowner’s or Renter’s Insurance Policy
- Garfield County Tax Bill indicating payment to PBMPRD
- Legal Dependents of Eligible Parents or Guardians [who reside in the district and/or attend a District 16 School] are eligible

NOT ACCEPTED:


Personal Letters, Solicitations, E-mails.

- Members must sign up in person.
- Persons over the age of 18 must sign a risk disclosure and complete an emergency notification sheet.
- In-District members who wish to utilize the Center will pay an Activation Fee at the first use each year.
- Activation fees are based on the calendar year.

WEIGHT ROOM

There is a one-time fee of \$5.00 for class / safety info.

All members and guests ages 14 to 17 must attend a “Weight Room Safety” class (approx. 1 hour) before being granted access to the weight room. **Adults** can waive the class but must go over all safety information.



- Required to hire the contracted Bartender through the Grand Valley Recreation Center.

- All alcoholic beverages must be purchased through All Social Matters, LLC

Any Parties/Events without Alcohol

- Must agree to no alcohol consumption in and/or outside the building.

Additional Information Regarding Room Rental

- A credit or debit card must be on file prior to any party to cover damage.
- Costs to clean soiled furniture, carpets and flooring [requiring extra cleaning] will be billed at actual cost.
- Courteous 48 cancelation is appreciated. Deposit is not refundable if rental is cancelled.
- Glitter and scotch tape cannot be used to decorate.
- Limited use (must be approved and extra set up charges apply determined on a per use basis).
- Tables and chairs up to 200 guests provided by GVRC at no extra charge, depending on availability.
- There will be a \$25.00 charge for every 15 minutes over scheduled room rental.
