



HCBS-SLS Provider Incentive Distribution

In January 2017, the Joint Budget Committee appropriated \$4,701,000 in funding from the IDD Cash Fund for a one-time incentive payment to Home and Community Based Services Supported Living Services (HCBS-SLS) providers. The Department used Fiscal Year 2015-16 claims data to proportionately distribute funds across providers based on the number of clients served. The Department has targeted providers that have a substantial claims volume and set a minimum claims threshold by client of \$2,000 for a provider to receive funding. The table below outlines the HCBS-SLS waiver provider distribution:
