*It was determined by the CDPHE Legal Department that the neglect statute only covers "at risk adults". At risk adults are patients/residents/clients over 18 years or older who are physically or mentally incapacitated. The Occurrence Team reviewed and deactivated neglect occurrences submitted as of 2/28/13 not meeting that criteria. It was also determined that "care givers", as defined in the statute, does not include physicians. Negligent practice involving physicians will no longer be reportable as an occurrence.
