AUTHORIZING TEMPORARY POSSESSION OF RADIOACTIVE MATERIAL PENDING DISPOSAL

INSTRUCTIONS: Persons may apply for a radioactive material license using Department Form OR-RH-12 as an alternative to this application for a Provisional License. This application must be signed and dated. File the original copy with the Colorado Department of Public Health and Environment, Radiation Management Program, 4300 Cherry Creek Drive South, Denver, Colorado, 80246-1530. All radioactive materials licenses are issued in accordance with the general requirements contained in the State of Colorado *Rules and Regulations Pertaining to Radiation Control* and 25-11, CRS 1989, Replacement Volume as amended.

COMMITMENTS:

- C.1. Within 180 days from the date of the issuance of a Provisional Radioactive Material License the Applicant named in Item 1 shall either:
- A. Lawfully dispose of all radioactive materials identified in Item 7 in accordance with the requirements of the State of Colorado *Rules and Regulations Pertaining to Radiation Control* or as authorized by the Department; or
 - B. Provide the Department with a characterization and risk assessment for the radioactive material identified in Item 7 and request that these materials be exempted from the requirements of the regulations; or
 - C. File a complete application with the Department for a specific radioactive material license with the required fee and financial assurance.

- C.2 A written plan for identification, characterization, and dispose of radioactive material will be provided to the Department within 30 days from the issuance of a provisional license. Copies of correspondence to and from waste brokers, analytical laboratories, and disposal facilities regarding the licensee's efforts to characterize and dispose of radioactive material will also be provided to the Department.
- C.3. Radioactive material will be stored in a manner that will preclude access and use by unauthorized personnel. Prior to any changes in the storage location written approval shall be obtained from the Department.
- C.4 Radioactive materials shall not be mixed with other materials for the purposes of dilution or commingled with any other wastes.
- C.5. Disposal or transfer of radioactive materials shall only be to persons authorized to receive these materials. Verification of the recipient's authorization shall be made prior to disposal or transfer. A copy of disposal or transfer records will be provided to the Department within 10 days of disposal or transfer.
- C.6. Transportation of radioactive material will be in accordance with all requirements of the U.S. Department of Transportation and Part 17 of the State of Colorado *Rules and Regulations Pertaining to Radiation Control*.
- C.7. The Applicant understands that only one extension to the provisional license for a period of up to 180 days may be granted upon written request of the licensee and written consent of the Department. The applicant also understands that such written request must be received by the Department at least 10 days prior to the expiration of the provisional license and shall state the reason and need for such an extension.
- C.8 The Applicant understands that the Department reserves its rights to require a Specific Radioactive Material License of the applicant or the provisional licensee.
- C.9. The applicant named in Item 1 shall remain responsible for control and ultimate disposal of all radioactive materials possessed under a radioactive materials license issued by the Department. The requirements of the license and the State of Colorado *Rules and Regulations Pertaining to Radiation Control* will remain in effect until the termination of the license by the Department, even if the license has expired.
