### Colorado NPI Law presented by Chris Underwood (Slides 8-9, Time 00:05:43-00:36:17)

- Revalidation
  - At least every 5 years
  - Starting April 2020
  - A six (6) month notice via email in advance of their enrollment deadline
  - Action: update email addresses in provider enrollment profiles to receive these notices
- Colorado NPI Law
  - Organization Health Care Providers (not individuals) must obtain and use unique and separate National Provider Identifier (NPI) for each **Service Location** and **Provider Type**
    - Impacts both Enrollment and Claims
  - New Providers and Sites: Jan 2020
  - Current Providers: Jan 2021
  - Draft Rules for Review: now available on our website

**Medicare Crossover Workaround Quick Update (Slide 14, Time 00:40:58-00:52:27)**

Department SCR prioritization is re-evaluated every two weeks. The Department considers factors such as:

- financial risk,
- impact on providers,
- relative magnitude, etc.

The Department is committed to moving forward with these important changes, and will continue to provide updates as they are available. (Chart provided)

**Community Clinic and Community Clinic and Emergency Center (CC/CCEC) Reminder (Slide 15, Time 00:52:27-00:54:01)**

The CC/CCEC rule became effective November 30, 2018. The adoption of this rule eliminated the temporary provision for locations licensed as CC/CCECs to be enrolled as and/or bill under the hospital provider type. (Table provided with enrollment statistics)

**Separating Baby from Mother's Claim (Slides 16-17, Time 00:54:01-01:02:46)**

How do we estimate the DRG-SOIs for 16,811 missing well-baby claims? (Chart included to reflect claim count)

**EAPG Module Updates (Slide 19, 01:03:10-01:04:49)**

- GPS v2019.1.0 Installed March 30, 2019
  - EAPG Grouper recognizes 4/1/2019 quarterly update to CPT/HCPCS
  - Version 3.10 remains in use
- Similar scheduling for GPS v2019.2.0
  - No exact date on 3M site – late June 2019 anticipated
  - No planned updates to grouping methodology
  - 7/1/2019 quarterly CPT/HCPCS updates

**Brief EAPG Rate Update (Slide 20, Time 01:04:49-01:06:43)**

- Annual rate change effective July 1, 2019
- No rule change required
- SPA update required, all rate updates pending CMS approval
- Online rate posting by 6/1/2019 for consistency with 7/1/2018 timeline of implementing rate change prior to rate effective date

**JW Modifier SCR (Slide 21, Time 01:06:43-01:09:17)**

- Background: Items billed with the 'JW' Modifier (discarded portion of drugs) generated payment in interChange system
  - Although requested to be billed, is not intended to have EAPG Payment
- SCR 44898 Created
  - Not yet prioritized
  - Once implemented, claims with DOS 10/31/2016 billed with JW modifier will be adjusted to pay properly

**Outpatient Hospital Survey (Slide 22, Time 01:09:17-01:23:04)**
