Enclosed please find a report to the Joint Budget Committee on the Health Care Policy and Financing expenditures and caseload for Medicaid and the Children's Basic Health Plan pursuant to FY 2011-12 Legislative Request For Information #1:

"The Department is requested to submit monthly Medicaid expenditure and caseload reports on the Medical Services Premiums and mental health capitation line items to the Joint Budget Committee, by the fifteenth or first business day following the fifteenth of each month. The Department is requested to include in the report the managed care organization caseload by aid category. The Department is also requested to provide caseload and expenditure data for the Children's Basic Health Plan, the Medicare Modernization Act State Contribution Payment, and the Old Age Pension State Medical Program within the monthly report."

The data contained in this month's Medicaid expenditure and caseload report is reflected as of October 31, 2011, coinciding with the close of Period 4 in the Colorado Financial Reporting System. The current report contains a separate worksheet for Medical Services Premiums expenditures by service category and Medicaid caseload data by eligibility category, which includes the monthly and over-the-year growth rates. Year-to-date caseload averages for clients in health maintenance organizations and the Primary Care Physician Program appear in the Medicaid caseload worksheet.

Please note the addition of an expenditure category for the Children's Basic Health Plan beginning with this report. Previous reports included expenditures for children's medical expenses, children's dental expenses, and prenatal medical expenses. Due to an accounting transfer of General Fund that results in a double counting of expenses, expenditures for the Children's Basic Health Plan are overstated in October 2011. The Department is researching how this transfer amount should be reflected in the Colorado Financial Reporting System and this amount may be reversed during FY 2011-12. In order to separate the amount of this double count, the Department is including a new column that includes only General Fund transfers for services that are already accounted for in the other columns.

This report also includes caseload and expenditure data for the Old Age Pension State Medical Program and the Medicare Modernization Act State Contribution Payments.

In addition to the information requested in Legislative Request For Information #1, the Department is including Medicaid Mental Health expenditure and caseload by Behavioral Health Organization pursuant to the FY 2008-09 Legislative Request For Information #26:

"The Department is requested to provide recommendations to the Joint Budget Committee by November 1, 2008 on whether greater budget accuracy would be achieved if caseload and capitation payments were estimated and tracked for each Regional Behavioral Center. In developing their recommendations, the Department will note any additional administrative costs associated with changing systems to track caseload data in this manner and to compile and report on the data."

Please note that the July 2011 bill for the Medicare Modernization Act State Contribution Payment was erroneously paid in both August and September 2011; the August 2011 bill should have been paid in September 2011. This was corrected in early October 2011, and the difference between the July and August 2011 bill will be reflected in the expenditures shown in the October 2011 report.
