- _____ _____ Redeemed tickets are rejected.
- _____ _____ Expired tickets are rejected.
- _____ _____ Ticket redemption kiosk indicates rejection condition either by displaying an error message or not accepting the ticket.
- _____ _____ Ticket amount is paid out correctly at the ticket redemption kiosk.
- _____ _____ The ticket redemption kiosk only redeems valid tickets for cash and tokens. Ensure that it does NOT generate and issue tickets. If it does/can generate and issue tickets, document.
- _____ _____ When the system link is down, the ticket is rejected. If not, document:
- _____ _____ Ticket redemption kiosk Ticket In or Voucher In and Ticket Out or Voucher Out meters are properly updated. Document the prior meter readings, insert the ticket, complete the transactions, and document the current meter reading.
- _____ _____ Ensure that the ticket redemption kiosk software is approved for use in Colorado.
