Communities That Care Funding Talking Points	<ul style="list-style-type: none"> <li>• Ali Maffey: Policy and Communication Unit Supervisor with CDPHE <a href="mailto:ali.maffey@state.co.us">ali.maffey@state.co.us</a></li> <li>• Resource included as attachment in email.</li> <li>• <u>Questions:</u> <ul style="list-style-type: none"> <li>• Why was this model chosen and are you working with the Office of Behavioral Health? They're using a similar framework, but not the same model.               <ul style="list-style-type: none"> <li>○ Initially, yes we were working with them, but decided not to continue the partnership with shared funding. We regularly communicate with them on things like aligning evaluation measures and strategies, etc.</li> </ul> </li> <li>• Was it arbitrary that you decided to use the CTC model?               <ul style="list-style-type: none"> <li>○ Funder (Gov's Office) requested to use CTC model for this particular funding.</li> </ul> </li> <li>• Can you send out the (menu) document you're reading from?               <ul style="list-style-type: none"> <li>○ The menu document information is not final, so it won't be shared at this time.</li> </ul> </li> <li>• What if a community has mental health as a priority area, but not substance abuse? Would they be eligible?</li> </ul> </li> </ul>



	<ul style="list-style-type: none"> <li>○ At this point, we believe so. We're looking at total award amount, 3.5 million is available. If funding amount from JBC is drastically changed, that could change this.</li> <li>• If we identified MH/SA in our county health assessment but did not pick it as a priority in our PHIP, are we still eligible?             <ul style="list-style-type: none"> <li>○ Yes.</li> </ul> </li> <li>• Could these funds be used to place a CTC coordinator in a school district?             <ul style="list-style-type: none"> <li>○ The model is bigger than just school level change, but if that is the correct convening entity, they're still engaging the broader community, and the other requirements are met, that would work.</li> </ul> </li> <li>• Is the Governor's Office wanting to make sure we show that we've used the CTC model in our community, i.e. we just have to show our evidence of how we've done that so we don't have to go through all of the steps again?             <ul style="list-style-type: none"> <li>○ Yes. We would want the coordinator to go through the training. Recommend taking a look at the CTC milestones and Benchmarks to ensure everything was taken into consideration and addressed before re-engaging.</li> </ul> </li> <li>• Are you going to send an official document for us to complete for a letter of intent or do you want us to just create something?             <ul style="list-style-type: none"> <li>○ Just create something and send to Ali Maffey so we know who the primary point of contact is.</li> </ul> </li> </ul>
