Dear Governor Hickenlooper, Senator Guzman, and Representative Hamner:

In accordance with CRS 24-75-204(2), attached is a report of loans and advances as of June 30, 2015. This report shows the outstanding loans and advances provided by the State Treasury to state departments and institutions of higher education for a wide range of activities including enterprise operations and cash funded state programs.

Approved and unapproved loans and advances outstanding at fiscal year-end totaled \$24.3 million. This is an increase of approximately \$18.3 million from the June 30, 2014 balance of \$6.0 million. Included in this total is \$20.1 million of approved loans and advances, primarily made up the Wildland Fire Cost Recovery Fund in the Department of Public Safety in the amount of \$9.6 million and the GOCO Distribution in the Department of Natural Resources in the amount of \$8.2 million.

The remaining \$4.2 million consists of unapproved loans and advances (see items marked with footnote 1 and 2 on the attached report). The State Fair Authority loan request from the Department of Agriculture in the amount of \$1.1 million was not approved by the Office of State Planning and Budgeting, due to ongoing operational concerns. Also, the State Public School Fund advance request from the Department of Education in the amount of \$2.4 million, and the Special Capital Construction Fund advance request, from the Department of Public Safety in the amount of \$0.6 million, were not approved by the Office of the State Controller, as these funds also had a deficit fund balance at the end of the fiscal year.

Interest on each approved loan is computed based on the monthly earnings rate on the treasury pool and interest is not charged on advances.

This report is for informational purposes and no further action is required.
