

NOTE: A new Retail Marijuana Establishment must pay the application fee plus the license fee at the time the application is made. A Medical Marijuana Business that converts to a Retail Marijuana Establishment must pay the application fee at the time the application is made, and the license fees will be due when the original Medical Marijuana Business license would have become due for renewal.
