April 5, 2015 – April 8, 2015	<b>Absentee Ballots Mailed to Voters Who Have Filed for an Absentee Ballot</b>
April 13, 2015 – April 20, 2015	<b>Ballots Mailed</b>  <i>(No sooner than 22 days and no later than 15 days before election)</i>

April 13, 2015 – May 5, 2015	<p><b>Mail Ballot Packages Available Upon Request to Eligible Electors Not Listed on the Property Owner or Registered Elector Lists, or Listed as Inactive Voters</b></p> <p><i>(No sooner than 22 days before the election through 7:00 p.m. on Election Day)</i></p>
Before April 15, 2015	<p><b>Notice of Election Published</b></p> <p><i>(No later than 20 days prior to election)</i></p>
Before April 15, 2015 Until After the Election	<p><b>Notice of Election Posted with Designated Election Official and the El Paso County Clerk and Recorder</b></p> <p><i>(No later than 20 days prior to election)</i></p>
April 20, 2015	<p><b>Last Day to Mail Ballot Packages</b></p>
April 20, 2015	<p><b>Election Judges Appointed by the Designated Election Official</b></p> <p><i>(At least 15 days prior to the election)</i></p>
April 20, 2015	<p><b>Canvass Board Appointed by the Designated Election Official</b></p> <p><i>(At least 15 days prior to the election)</i></p>
May 5, 2015	<p><b>Replacement Ballots can be Requested until 7:00 p.m. on Election Day</b></p>
May 5, 2015	<p><b>ELECTION DAY</b></p> <p><i>(Ballots must be received at the Office of the Designated Election Official no later than 7:00 p.m. on Election Day in order to be counted.)</i></p>

June 2, 2015	<p><b>Last Day for Election Recount</b></p> <p><i>(No later than the 28<sup>th</sup> day after the election)</i></p>
June 4, 2015	<p><b>Election Results Certified to the Division of Local Government</b></p> <p><i>(Within 30 days after the election)</i></p>
