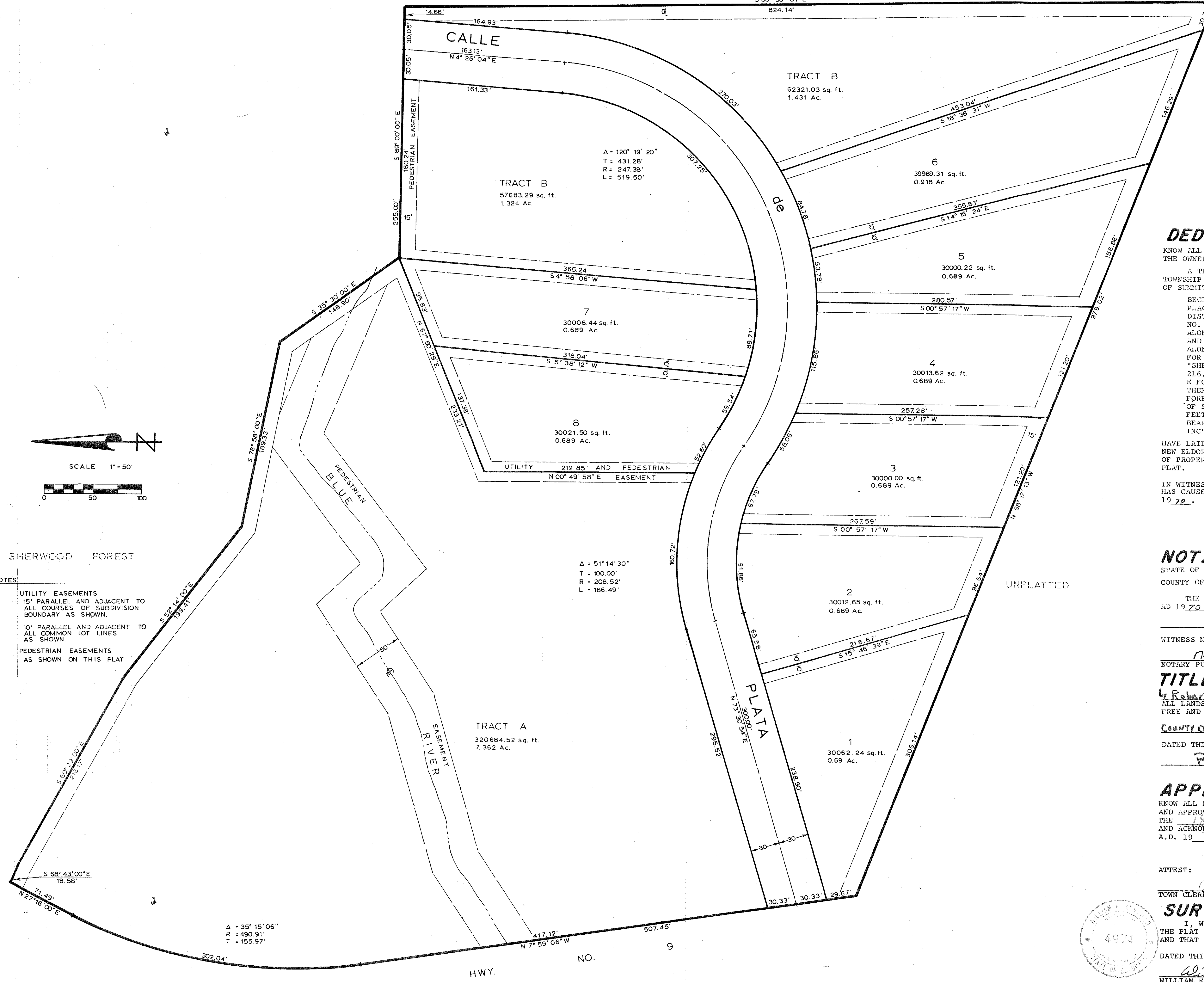

KNOW ALL MEN BY THESE PRESENTS: THAT SKI COUNTRY INVESTMENTS, INC., A COLORADO CORPORATION, BEING THE OWNER OF THE FOLLOWING DESCRIBED PROPERTY,
A TRACT OF LAND SITUATED IN THE "97" PLACER, U.S. MINERAL SURVEY NO. 13356, IN SECTION 30, TOWNSHIP 7 SOUTH, RANGE 77 WEST OF THE SIXTH PRINCIPAL MERIDIAN, IN THE TOWN OF BLUE RIVER, COUNTY OF SUMMIT, STATE OF COLORADO, TO-WIT:

LINE OF COLORADO STATE HIGHWAY NO. 9; THENCE N 07° 59' 06" W ALONG SAID R.O.W. FOR A DISTANCE OF 507.45 FEET; THENCE ALONG SAID R.O.W. AND TO THE RIGHT ALONG THE ARC OF A CURVE WHOSE DELTA IS 35° 15' 06" AND WHOSE RADIUS IS 490.91 FEET FOR A DISTANCE OF 302.04 FEET; THENCE N 27° 16' 00" E ALONG SAID R.O.W. FOR A DISTANCE OF 71.49 FEET; THENCE S 68° 43' 00" E ALONG SAID R.O.W. FOR A DISTANCE OF 18.58 FEET TO A POINT WHICH IS THE SOUTHWEST CORNER OF LOT 36 OF THE "SHERWOOD FOREST - BLUE RIVER ESTATES, INC."; THENCE S 60° 29' 00" E FOR A DISTANCE OF 216.17 FEET, THENCE S 52° 14' 00" E FOR A DISTANCE OF 199.41 FEET; THENCE S 70° 58' 00" E FOR A DISTANCE OF 189.33 FEET; THENCE S 35° 30' 00" E FOR A DISTANCE OF 148.90 FEET; THENCE S 89° 00' 00" E FOR A DISTANCE OF 255.00 FEET TO THE CORNER OF SAID "SHERWOOD FOREST - BLUE RIVER ESTATES, INC.", SAID SOUTHWEST CORNER BEING A POINT ON THE EAST LINE OF SAID "97" PLACER; THENCE S 00° 30' 01" E ALONG SAID EAST LINE FOR A DISTANCE OF 824.14 FEET TO THE POINT OF BEGINNING.
