SUBJECT: NOTICE OF PUBLIC HEARING TO CONSIDER ADOPTION OF
PERMANENT RULES

The State Controller (“Controller”) will hold a public hearing on Monday, July 30, 2018 to consider repeal and adoption of permanent rules for the Department of Personnel & Administration, Division of Finance and Procurement State Fiscal Rules.

The July 30, 2018 public hearing will commence at 2:00 p.m. at 1525 Sherman St., Room 104 (First Floor), Denver, Colorado 80203.

All interested persons are invited to attend this public hearing and to submit comments to the Controller for consideration concerning the proposed rules.

This rulemaking hearing will consider the same repeal and adoption of State Fiscal Rules as a previous rulemaking - hearing noticed on March 28, 2018; Secretary of State tracking number 2018-00117. Docket 2018-00117 was terminated before its completion. If you commented to docket 2018-00117 you do not have to resubmit your comments. All comments and testimony provided to that docket will become part of the record in this docket and considered in this rulemaking.

The Hearing Officer will take comments as follows:

3. Oral comments may be provided at the hearing as follows:
 - a. All persons wishing to provide oral comment must sign up to do so at the hearing, noting who they represent.
 - b. Any person signing up to speak may cede any portion or all of their time to another speaker.
 - c. At his discretion, the Hearing Officer may limit or extend the time of any speaker.

The State Controller will consider adoption of new permanent rules to the Department of Personnel & Administration Procurement Rules at 1-CCR-101-1.
