

Ordinance No. 170
Concerning Taxes

Be it Ordained by the Board of Trustees, of the Incorporated Town of Las Animas, Colorado. That the following levy shall be made for taxes for the year of 1906, to Wit:

Section 1.

Then shall be levied and collected, a tax of (6) six mills, upon each one Dollar of the assessed valuation, of the Town of Las Animas, Colorado for the water works interest fund.

Section 2

Then shall be levied and collected, a tax of Twenty (20) mills upon each one dollar of the assessed valuation, of the Town of Las Animas, Colorado for General Purposes.

Section 3

Because of the protection offered, in case a fire; there shall be levied and collected; a tax of one dollar, upon each lot of the town of Las Animas, Colorado, abutting on the water main of said town, the same being further described, as follows, to Wit:
