

Ordinance No.177

An Ordinance providing for the submission to the Vote of the Qualified Electors of the Town of Las Animas, at the regular Election of said Town to be held on the 2nd. day of April, AD 1907, the quarter of authorizing the Board of Trustees of said Town to Erect, make and construct estensions of and additions to the Water system of the Town of Las Animas, to be owned, managed and operated by the said Town.

Be it ordained by the Board of Trustees of the Incorporated Town of Las Animas, Colorado.

Section 1.

That at the regular Election of Municipal officers of said Town of Las Animas, Colorado, to be held in the City Hall in the Town of Las Animas, in the County of Bent and State of Colorado, on the 2nd day of April, A.D. 1907, the question of authorizing the Board of Trustees of said town to erect, make and construct extensions of and additions to the system of water works for fire and domestic purposes now owned and operated by said Town, said Extensions of and additions to said Water Works system to be owned, managed and operated by the said Town, be and the same is hereby submitted to such voters of said town of Las Animas, Colorado, as are tax payers under the law for there determination.

Section 2

The question so submitted shall be voted on at said election by the Voters qualified as aforesaid at the following place, to-wit: At the City Hall of Las Animas, in the County of Bent and State of Colorado.

Section 3

The Ballots to be used in voting upon the said question shall be prepared and furnished by the Town Clerk of said Town of Las Animas, to the Judges of election, to be by them furnished to the voters and shall be in the following printed form, to wit:

For the erection and construction of extension of and additions to the system of water works for fire and domestic purposes, now owned and operated by the Town of Las Animas, Colorado, and said extensions and additions to be owned, managed and operated by the said Town.

Against the erection and construction of extensions of and additions to the system of water works for fire and domestic purposes now owned and operated by the Town of Las Animas, Colorado, said extensions and additions to be owned, managed and operated by the said Town.

Section 4

Said ballots shall be cast by each voter by marking an x opposite his choice in the manner now provided by law for voting upon amendments to the Constitution of the State of Colorado.

Section 5

No ballots for or against said question shall be received by the Judges of election unless the person offering the same shall be a voter of the Town of Las Animas, Colorado, and a tax payer under the law of the State of Colorado.

Section 6

The vote upon said question shall be canvassed and returned and the result declared in the manner prescribed by the laws of the State of Colorado.

Section 7

This ordinance shall be published in the Bent County Democrat, a weekly newspaper of general circulation, published at Las Animas, in the County of Bent and State of Colorado, and by sending copies thereof to the Judges of election to be by then posted at the place of voting at least fifteen days before the date of said election of Municipal Officers of the said Town of Las Animas, Colorado.

Section 8

The Town Clerk of the Town of Las Animas, is hereby charged to effectuate this ordinance.
