

ORDINANCE NO. 376

*Adopting by REFERENCE THE*

AN ORDINANCE FOR THE REGULATION OF TRAFFIC UPON PUBLIC STREETS OF THE CITY OF LAS ANIMAS, COLORADO, "MODEL TRAFFIC CODE FOR COLORADO MUNICIPALITIES, COLORADO, 1966", <sup>*Providing Penalties for its Violation*</sup> AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT THEREWITH.

Be it ordained by the City Council of the City of Las Animas, Bent County, Colorado:

SECTION 1. Pursuant to Chapter 139, Article 34, CRS 1963, there is hereby adopted for the purpose of regulating traffic within the City of Las Animas, Bent County, Colorado, that certain Ordinance known as "The Model Traffic Code for Colorado Municipalities, 1966" officially approved, adopted and published as such by the Colorado Highway Safety Council and hereinafter referred to as the "Municipal Traffic Code" of which three copies are now filed in the office of the City Clerk and may be inspected during regular business hours, the same being adopted as if set out at length.

SECTION 2. PENALTIES FOR VIOLATIONS. - The following penalties, herewith set forth in full, shall apply to <sup>*violations of*</sup> the provisions of the municipal traffic code hereinafter adopted:

(a) It is unlawful for any person to violate any of the provisions of the Municipal Traffic Code and any such violations shall be punishable as is ~~hereinafter~~ <sup>*provided in Subsection (b) of this section.*</sup>

(b) Every person convicted of a violation of any provision of this Ordinance shall be punished by a fine of not more than Three Hundred Dollars, (\$300.00), or by imprisonment for not more than Ninety (90) days, or by both such fine and imprisonment.

(c) This Section shall be designated as Sec. 26-2 of said Municipal Traffic Code.

SECTION 3. EFFECTIVE DATE. - This Ordinance and the Municipal Traffic Code which is herein adopted by reference shall take effect from and after <sup>*APRIL*</sup> ~~May~~ 20, 1968. This Section shall be designated as Sec. 27-6 of said Municipal Traffic Code.
