

ORDINANCE NO. 389

AN ORDINANCE APPROVING THE EXPENDITURE OF FUNDS IN EXCESS OF THE BUDGET AND MAKING A DEFICIENCY APPROPRIATION FOR THE CALENDAR YEAR 1970

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LAS ANIMAS THAT:

WHEREAS, a state of emergency now exists within the City of Las Animas concerning the infestation of elm trees by elm beetles, their larvæ and other pests so that not only do such infested and infected trees and the potential loss thereof constitute a hazard to the health, safety and welfare of the inhabitants, but the same are a further hazard to their health, safety and general welfare due to the excretion from such infested or infected trees alighting upon automobiles, windows and sidewalks; and

WHEREAS, the City of Las Animas finds it necessary to expend funds in excess of budgeted allocations, to meet this emergency and eradicate this nuisance through the spraying or treating of elm trees; and

WHEREAS, the expenditure for such purposes will be in excess of funds budgeted for the calendar year 1970 in the amount of \$12,000.00; and

WHEREAS, the expenditure of such funds could not be foreseen at the time of preparation and adoption of the annual budget;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Las Animas that the expenditure of funds in excess of the budget for the calendar year 1970 in the amount of \$12,000.00, be and the same is hereby approved, and the City Clerk directed to make a deficiency appropriation therefor.

The City Council finds that an emergency exists and that this Ordinance is necessary for the immediate preservation and protection of the public health, property and welfare.
