

ORDINANCE NO. 451 A

AN EMERGENCY ORDINANCE AUTHORIZING THE LAS ANIMAS MUNICIPAL LIGHT AND POWER COMPANY TO PURCHASE A 1979 CHEVROLET MALIBU AUTOMOBILE FROM THE KESTER MOTOR COMPANY, LAS ANIMAS, COLORADO, FOR \$5,170.00.

WHEREAS, The Las Animas Municipal Light and Power Company is owned by the City of Las Animas, Colorado, and

WHEREAS, the Las Animas Municipal Light and Power Company asked for bids from the Kester Motor Company, Las Animas, Colorado, and the Bent County Motor Company, Las Animas, Colorado, on January 12, 1979, for a 1979 automobile, and

WHEREAS, specifications for such 1979 automobile were as follows:

- a. 8-cylinder motor
- b. Power brakes
- c. Power steering
- d. Automatic transmission
- e. Intermediate size car
- f. Radio, heater, defroster, and air conditioner
- g. Complete with standard safety equipment, also regular spare tire and wheel, radial black-wall tires,

and

WHEREAS, The Las Animas Municipal Light and Power Company listed in the bid a trade-in of a 1971 Ford, 4-door sedan, serial no. IP51V151273, 8-cylinder standard shift, and

WHEREAS, The Las Animas Municipal Light and Power Company has received bids from the aforementioned automobile sales companies, and

WHEREAS, on February 12, 1979, the Board of Electric Public Utilities Commissioners approved the low bid for such automobile which was submitted by the Kester Motor Company, Las Animas, Colorado, and

WHEREAS, such low bid was in the amount of \$5,170.00, and

WHEREAS, the present vehicle owned and operated by the Las Animas Municipal Light and Power Company is in need of repair and is a safety hazard.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LAS ANIMAS, COLORADO:

That the Las Animas Municipal Light and Power Company is authorized to make payment to the Kester Motor Company, Las Animas, Colorado, in the amount of \$5,170.00, together with a trade-in of a 1971 Ford 4-door Sedan automobile, Serial no. IP51V151273, as full compensation for a 1979 Chevrolet Malibu automobile, whose specifications are those shown above, and

That the passage of this Ordinance is necessary to the immediate preservation of the public health and safety of the City of Las Animas, Colorado.
