

ORDINANCE NO. 461

AN EMERGENCY ORDINANCE AUTHORIZING THE LAS ANIMAS MUNICIPAL LIGHT AND POWER COMPANY TO SPEND \$510,788.00 TO EXPAND THEIR ELECTRICAL DISTRIBUTION SYSTEM, AND TO PAY FOR SAID EXPANSION FROM FUNDS SET ASIDE THEREFORE.

WHEREAS, the Las Animas Municipal Light and Power Company is owned by the City of Las Animas, Colorado, and

WHEREAS, the Las Animas Municipal Light and Power Company is in the process of expanding its electrical distribution system by building a new loop circuit on the north side of the City of Las Animas, and by building a new electrical substation at Fort Lyon, Colorado, and

WHEREAS, it is estimated that the completed project will cost the Las Animas Municipal Light and Power Company a total of \$615,000.00,

WHEREAS, Ordinance No. 452 was adopted by the Las Animas City Council authorizing the expenditure of \$104,212.00 for the purchase of a substation transformer as part of the equipment for such expansion, and the Las Animas Municipal Light and Power Company has purchased and paid for such transformer, and

WHEREAS, there remains the sum of \$510,788.00 to be approved as an expenditure of the system, and

WHEREAS, the City Council of the City of Las Animas, Colorado, has previously approved the expansion of the electrical system of the Las Animas Municipal Light and Power Company, and

WHEREAS, the Las Animas Municipal Light and Power Company has reserves set aside to pay for said expansion of the electrical system.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LAS ANIMAS, COLORADO:

That the Las Animas Municipal Light and Power Company is authorized to spend the sum of \$510,788.00 to complete the expansion of the electrical system which includes the building of a new loop circuit on the north side of the City of Las Animas, Colorado, and the construction of a substation at Fort Lyon, Colorado, and

That the passage of this Ordinance is necessary for the immediate preservation of the public health and safety of the City of

Las Animas, Colorado.
