

AN ORDINANCE RELATING TO THE REGULATION OF THE ERECTION, INSTALLATION, ALTERATION, ADDITION, REPAIR, RELOCATION, REPLACEMENT, MAINTENANCE, OR USE OF ANY PLUMBING SYSTEM IN THE CITY OF LAS ANIMAS, COLORADO: ADOPTING BY REFERENCE THERETO THE UNIFORM PLUMBING CODE, 1982 EDITION, OF THE NATIONAL ASSOCIATION OF PLUMBING AND MECHANICAL OFFICIALS; REPEALING ALL ORDINANCES OF THE CITY OF LAS ANIMAS, COLORADO, IN CONFLICT OR INCONSISTENT HERewith; AND PROVIDING A PENALTY FOR VIOLATION OF THE PROVISIONS OF SAID ~~ELECTRICAL~~ CODE.  
PLUMBING

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LAS ANIMAS, COLORADO:

Section 1. Adoption. Pursuant to Title 31, Article 16, Part 2, Colorado Revised Statutes, 1973, as amended, there is hereby adopted as the Plumbing Code of the City of Las Animas, by reference thereto, the Uniform Plumbing Code, 1982 Edition, published by the International Association of Plumbing and Mechanical Officials, 5032 Alhambra Avenue, Los Angeles, California 90032. The subject matter of the adopted codes includes comprehensive provisions and standards regulating the erection, installation, alteration, addition, repair, relocation, replacement, maintenance, or use of any plumbing system for the purpose of protecting the public health, safety, and general welfare.

Section 2. a. Amendments. Appendix I of said Uniform Plumbing Code relating to individual sewage disposal systems is hereby amended where it is in conflict with Chapter 25, Article 10, of the Colorado Revised Statutes, 1973, as amended, to conform to and comply with said Chapter 25, Article 10, of C.R.S., 1973, as amended.

b. Deletions. None.

Section 3. Code Copies. At least three (3) copies of the Uniform Plumbing Code, 1982 Edition, of the International Association of Plumbing and Mechanical Officials certified to be a true copy, is now and has been on file in the office of the City Clerk, and may be inspected by any interested person between the hours of 8:00 a.m. and 5:00 p.m., Monday through Friday, holidays excepted. The "Plumbing Code" as finally adopted shall be available for sale to the public through the office of the City Clerk at a moderate price.

Section 4. Penalties. The following penalty clauses contained in the Uniform Plumbing Code, 1982 Edition, is hereby set forth in full and adopted:

"Section 20.3. Any person, firm, or corporation violating any provision of this code shall be deemed guilty of a misdemeanor and upon conviction thereon, shall be punishable by a fine not to exceed THREE HUNDRED DOLLARS (\$300.00) or by imprisonment in the city or county jail for not to exceed three months (90 days) or both fine and imprisonment. Each separate day or any portion thereof, during which any violation occurs or continues, shall be deemed to constitute a separate offense and upon conviction thereof, shall be punishable as herein provided."

Section 5. Savings Clause. If any part, section, subsection, sentence, clause, or phrase of this Ordinance or of the Plumbing Code adopted hereby is for any reason held to be invalid, such decisions shall not affect by validity of the remaining sections of this Ordinance or of said Plumbing Code; the City Council hereby declares that it would have passed this Ordinance and adopted said Plumbing Code in each part, section, subsection, sentence, clause, or phrase thereof, irrespective of the fact

that any one or more parts, sections, subsections, sentences, clauses or phrases be declared invalid.


Section 6. Repeal. Any or all Ordinances or parts of Ordinances of the City of Las Animas, in conflict or inconsistent herewith are hereby repealed, provided, however, that the repeal of any Ordinance or parts of Ordinances of the City of Las Animas shall not revive any other section of any Ordinance or Ordinances heretofore repealed or superseded. Ordinance number 377 is hereby specifically repealed in its entirety.
