

ORDINANCE NO. 112

AN ORDINANCE CHANGING THE NAMES OF CERTAIN STREETS AND AVENUES IN THE TOWN OF NUCLA AND CONFIRMING AND RATIFYING ALL REFERENCES TO SUCH CHANGES.

WHEREAS, a certain "amended plat of the Town of Nucla, Colorado" is on file in the office of the County Clerk and Recorder for the County of Montrose and State of Colorado in Plat Book 6 at Page 41, and

WHEREAS, the said "amended plat of the Town of Nucla, Colorado" names and numbers certain streets and avenues within the Town of Nucla, Colorado, and

WHEREAS, during years subsequent to the filing of said plat, the Town of Nucla at some unknown point in time changed the names of certain streets and avenues within the Town of Nucla but apparently such changes were not authorized or approved by ordinance, and

WHEREAS, Mr. Harold D. ~~Stevens~~ a registered land surveyor in the State of Colorado has prepared a plat of the Town of Nucla from the said "amended plat of the Town of Nucla, Colorado" which plat also reflects the names changed with respect to the said streets and avenues, and

WHEREAS, it is the desire of the Board of Trustees for the Town of Nucla, Colorado, to adopt the said name changes, and

WHEREAS, the said plat reflecting such changes is filed in Plat Book 10 at Page 143 in the office of the County Clerk and Recorder for the County of Montrose and State of Colorado, now, therefore, be it resolved:

SECTION 1. NAME CHANGES. The streets and avenues designated on the "amended plat of the Town of Nucla, Colorado" on file in the office of the County Clerk and Recorder for the County of Montrose and State of Colorado in Plat Book 6 at Page 41 are hereby changed from the numbers and names therein designated to the numbers and names designated in the plat of the Town of Nucla on file in the office of the Clerk and Recorder for the County of Montrose and State of Colorado in Plat Book 10 at Page 143.

SECTION 2. PRIOR REFERENCES. Any and all prior references to the names of the streets and avenues as so changed are hereby ratified and approved.

SECTION 3. A COPY OF THIS ORDINANCE SHALL BE RECORDED IN THE OFFICE OF THE CLERK AND RECORDER FOR THE COUNTY OF MONTROSE AND STATE OF COLORADO AND THE PROPER OFFICIALS FOR THE TOWN OF NUCLA WILL ALSO RECORD A COPY OF ALL ANNEXING ORDINANCES PREVIOUSLY ADOPTED AND PASSED BY ORDINANCES.
