ORDINANCE NO. 33

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 19 OF THE TOWN OF NUCLA BEING "AN ORDINANCE AMENDING AND ESTABLISHING RATES FOR WATER FURNISHED BY THE MUNICIPAL WATER WORKS SYSTEM OF THE TOWN OF NUCLA, COLORADO, REPEALING ALL ORDINANCES OR PARTS THEREOF IN CONFLICT HEREWITH PROVIDING FOR VIOLATIONS AND PENALTIES AND DECLARING AN EMERGENCY."

WHEREAS, The costs of operating and maintaining the Water Works System of the Town of Nucla have increased, and

WHEREAS, Provision must be made for water rates and charges sufficient to pay the cost of operating and maintaining said system and liquidate the indebtedness thereon;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF NUCLA, COLORADO:

Section 1. Section 1 of Ordinance No. 19 of the Town of Nucla, Colorado, is hereby amended to read as follows:

"Section 1. That there shall be charged water rates which shall be sufficient to pay the cost of operating and maintaining such system, and to pay the interest on and principal of said refunding bonds. Until revised by order of the Board of Trustees, such water rates shall be as follows:

- A.
- With residence without toilet or bath      \$3.00 per month
- With Toilet or bath      \$3.25 per month
- With Toilet and bath      \$3.50 per month
- With each additional toilet or bath      \$ .25 per month
- Carrying charges      \$ .75 per month

Bath shall be construed to mean either tub or shower.

Any dwelling where the occupant keeps two or more boarders or roomers shall be considered as a business establishment and shall pay rates pertaining thereto.

Anyone maintaining a separate establishment, whether room or apartment shall be considered same as any other dwelling or business.

B. The following rules shall be made applicable to all business houses:

For all Grocery Stores, General Merchandise Stores, Offices and Miscellaneous Establishments the following rates:

- Without toilet or bath      \$3.00 per month
- With toilet      \$3.50 per month
- With each additional toilet or bath      \$ .50 per month

For Barber Shops, Pool Halls, Service Stations, Garages, Locker Plants, Repair Shops, Theaters, Flour Mills and like establishments:

- Without toilet or bath      \$3.00 per month
- With each toilet or bath      \$ .50 additional per month

For Hotels and Restaurants, Rooming Houses:

Without Toilet or bath	\$4.50 per month
Each toilet	\$ .50 additional per mo
Each bath	\$1.00 additional per mo

For Soda Fountains and Beauty Parlors	\$4.00 per month
For Creamery and Laundry	\$11.00 per month

Business houses or dwellings located outside of the City Limits shall be charged a 50% higher rate.

Any person keeping cattle or horses and watering same from city water shall pay \$1.00 per head per month as long as a sufficient supply of water is available--payable quarterly in advance.

C. Water for irrigation:

2 lots or less	\$5.00 per season
For each lot over 2 lots	\$2.50 per lot.

Section 2. All ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

Section 3. It is hereby declared that an emergency exists and that this Ordinance as a sanitary and police measure, is necessary for the immediate preservation of the public peace, health and safety.
