

ORDINANCE NO. 357

AN ORDINANCE TO AMEND SECTION 2-3-60, 2-3-70, 2-3-80 AND 2-3-90 OF CHAPTER 2 OF THE CREEDE MUNICIPAL CODE REGARDING APPOINTMENTS

WHEREAS, the City of Creede (City), a Colorado Town is a municipal corporation and political subdivision of the State duly organized and operating as a statutory town; and

WHEREAS, pursuant to CRS 31-15-103, municipalities have the authority to enact, publish and enforce ordinances, codes and regulations; and

WHEREAS, the City of Creede has determined that it is necessary to promote the prosperity, order, consistence and convenience to amend the above sections accordingly; and

WHEREAS, Section 2-3-60 of the Creede Municipal Code reads: The Board of Trustees, at its first regular meeting of each calendar year shall appoint a City Manager; and

WHEREAS, Section 2-3-70 of the Creede Municipal Code reads: The Board of Trustees at its first regular meeting after each biennial election shall appoint some qualified person as City Clerk; and

WHEREAS, Section 2-3-80 of the Creede Municipal Code reads: The Board of Trustees, at its first regular meeting after each biennial election shall appoint some qualified person as City Treasurer; and

WHEREAS, Section 2-3-90 of the Creede Municipal Code reads: The Board of Trustees, at its first regular meeting after each biennial election shall appoint some qualified attorney at law as City Attorney; and

WHEREAS, these appointments are recorded by resolution effective the first of every year and are recorded as the first resolution of every year; and

WHEREAS, these appointments should be consistent with the operations of the City.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE CITY OF CREEDE, THAT:

Section 1: These appointments are effective the beginning of every year and need to be approved by the Board of Trustees at their last meeting of the year to be recorded as the first Resolution of the next year.

Section 2: The first sentence in Section 2-3-60 of the Creede Municipal Code will be amended to read: The Board of Trustees, by its first regular meeting of each calendar year, shall approve the appointment of the City Manager.

Section 3: The first sentence in Section 2-3-70 of the Creede Municipal Code will be amended to read: The Board of Trustees, by its first regular meeting of each calendar year, shall approve the appointment of the City Clerk.


Section 4: The first sentence in Section 2-3-80 of the Creede Municipal Code will be amended to read: The Board of Trustees, by its first regular meeting of each calendar year, shall approve the appointment of the City Treasurer.

Section 5: The first sentence in Section 2-3-90 of the Creede Municipal Code will be amended to read: The Board of Trustees, by its first regular meeting of each calendar year, shall approve the appointment of the City Attorney.
