

ORDINANCE NO. 30A

AN ORDINANCE ADOPTING AND APPROVING AN INCREASE IN THE MONTHLY SERVICE CHARGE FOR BASIC CABLE SERVICE, MADE BY CUSTOM CABLE SYSTEMS, INC., A COLORADO CORPORATION, ITS SUCCESSORS AND ASSIGNS TO CONSUMERS WITH FACILITIES TO BE SERVICED LOCATED WITHIN THE INCORPORATED LIMITS OF THE TOWN OF STRATTON, COLORADO, OR ANY LEGAL ANNEXATIONS THERETO.
