

AN ORDINANCE APPROPRIATING SUMS FOR ALL MUNICIPAL PURPOSES OF THE TOWN OF STRATTON FOR THE CALENDAR YEAR 1990, CONSTITUTING WHAT IS TERMED THE ANNUAL APPROPRIATION BILL FOR SAID FISCAL PERIOD.

THE BOARD OF TRUSTEES OF THE TOWN OF STRATTON, COLORADO ORDAINS:

Section 1. That there be and there is hereby appropriated from all sources of revenue of the Town of Stratton for the calendar year 1990 beginning January 1, 1990, and ending December 31, 1990, the amount hereinafter set forth for the object and purpose specified and set opposite thereto, specially as follows to wit:

GENERAL FUND-----	282,557
WATER FUND-----	81,600
CONSERVATION TRUST FUND-----	10,500
LIBRARY FUND-----	15,724

Section 2. The foregoing appropriations shall be considered to be appropriations to groups within a program or department within the fund indicated, but shall not be constructed to be appropriations to line items within any group, even though such line items may be set forth in the adopted budget for the calendar year 1990.

Section 3. That all monies in the hands of the Town Clerk or Town trasurer to come into their hands for the calendar year 1990 may be so distributed among the respective funds herein as the Board of Trustees may deem best under such control as is provided by law.


Section 5. That during or at the close of the calendar year, any surplus money in any of the respective funds, after all calims against the same have been paid, may be distributed to any other fund or funds in the descretion of the Board of Trustees.

Section 6. The Board of Trustees find and declares that this Ordinance is necessary for the immediate preservation of the public peace, health and safety and therefore, an emergency exists and the Ordinance shall be ceome effective five days after publication thereof.


