

ORDINANCE TO APPROPRIATE SUMS OF MONEY

AN ORDINANCE APPROPRIATING SUMS OF MONEY TO THE VARIOUS FUNDS, IN THE AMOUNTS AND FOR THE PURPOSES AS SET FORTH BELOW, FOR THE TOWN STRATTON, COLORADO, FOR THE 1995 BUDGET YEAR.

WHEREAS, the Board of Trustees has adopted the annual budget in accordance with the Local Government Budget Law, on December 14, 1994, and;

WHEREAS, the Board of Trustees has made provision therein for revenues in an amount equal to or greater than the total proposed expenditures as set forth in said budget, and;

WHEREAS, it is not only required by law, but also necessary to appropriate the revenues provided in the budget to and for the purposes described below, so as not to impair the operations of the Town.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF STRATTON, COLORADO:

**RESOLUTION AND ORDER OF THE BOARD OF

**WHEREAS**, The Town of Stratton has submitted a Project Application to The State Board of the Great Outdoors Colorado Trust Fund. The name of the project is "Stratton Swimming Pool/Tennis Courts" described as "Development of swimming pool and tennis courts", copy of which is attached hereto identified as Exhibit A and incorporated herein by reference, and

**WHEREAS**, The State Board of the Great Outdoors Colorado Trust Fund approved the said Project Application on March 21, 1995 subject to the conditions set forth in the Grant Agreement, and

**WHEREAS**, The Town of Stratton anticipates the Stratton Swimming Pool/Tennis Courts Project will be substantially completed on October 31, 1995, and
