**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Follow all applicable directions, restrictions and precautions on the EPA registered label. This labeling must be in the possession of the user at the time of pesticide application.

**TREES AND SHRUBS:** Alder, American Elm, Aspen, Ash, Birch, Boxwood, CrapeMyrtle, Dogwood, Euonymus, Hackberry, Hawthorn, Honeylocust, Honeysuckle, Linden, Maple, Oak, River Birch, Roses, Snowball Viburnum, Spirea, Spruce, and Willow.

<b>SOIL INJECTION</b> Apply the specified amount of <i>Orthene</i> Turf, Tree & Ornamental WSP as a soil injection.	Aphids, Spider mites, Ash Sawfly	$\frac{1}{8}$ – $\frac{1}{4}$ oz. per inch diameter of trunk at breast height (DBH)  Or  $\frac{1}{8}$ – $\frac{1}{4}$ oz. per 100 sq. ft. of area under the dripline of the tree or shrub.	A minimum of two (2) injection sites per inch Diameter at Breast Height (DBH) is required. For multi-stemmed trees and shrubs, use diameter of individual canes at soil line instead of DBH. Apply one (1) quart of diluted solution per injection site. Injection sites should be evenly distributed between base of trunk and dripline of canopy. (Exceptions to this use are listed under "Use Precautions").  Make a minimum of four (4) injections per 25 sq ft of area under the dripline of the tree or shrub, using a grid pattern. Apply at least six (6) oz of dilute solution per injection site.  Do not apply more than 6-2/3 lbs of product per acre (2.45 oz of product per 1,000 sq ft of area under the dripline of the tree or shrub) per application.
<b>USE PRECAUTIONS:</b> Use injection equipment that can be accurately calibrated. Injections must reach a minimum depth of six (6) inches. For optimal uptake, irrigate the treated area after injecting to promote absorption into the root system. Do not apply more than once per month. Application to dry soil may decrease performance. Performance will be optimized by thorough and uniform application to the treated root system. Do not apply to areas where food crops are grown (i.e., vegetable gardens, fruit trees, berry vines, etc.), children's play areas, or animal runs.			

## Trunk Diameter Application Method

To apply 1/8 oz per inch DBH: Note: Use two injection sites per inch DBH, with one quart solution per injection site.	Mix three, 1/3 lb water soluble packets of <i>Orthene</i> TT&O WSP + 256 qts water to treat 128 inches of trunk diameter.
To apply 1/4 oz per inch DBH: Note: Use two injection sites per inch DBH, with one quart solution per injection site.	Mix three, 1/3 lb water soluble packets <i>Orthene</i> TT&O WSP + 128 qts water to treat 64 inches of trunk diameter.

## Under Dripline Application Method

Rate of <i>ORTHENE</i> Turf Tree & Ornamental WSP	Mixing Directions
To apply 1/8 oz per 100 sq ft under dripline: Note: Injections to be made in a grid pattern throughout the area under the dripline spaced 2.5 feet apart. Apply 6 oz diluted solution per injection site.	Mix one, 1/3 lb water soluble packet of <i>Orthene</i> TT&O WSP + 32 gals water to treat 4266 sq ft Mix three, 1/3 lb water soluble packets of <i>Orthene</i> TT&O WSP + 96 gals water to treat 12,798 sq ft
To apply 1/4 oz per 100 sq ft under dripline: Note: Injections to be made in a grid pattern throughout the area under the dripline spaced 2.5 feet apart. Apply 6 oz diluted solution per injection site.	Mix one, 1/3 lb water soluble packet of <i>Orthene</i> TT&O WSP + 16 gals water to treat 2,132 sq ft Mix three, 1/3 lb water soluble packets of <i>Orthene</i> TT&O WSP + 48 gals water to treat 6,399 sq ft
