Applications with a weed size of 6 inches or below will allow for the greatest control. Make one broadcast application. Use a nonionic surfactant (NIS).</p> <p>Tank Mixtures: Refer to the specific product labels and observe all precautions, mixing and application instructions for all products used in tank mixtures. Be sure to follow the specifications listed on the most restrictive label when planning and making applications. Tankmixtures for additional broadleaf weed control can be added.
