I understand that participation in the aforementioned programs involves certain risks, which could cause serious injury. On behalf of my child, who is voluntarily enrolled in the recreation department programs, I acknowledge the danger involved and agree to accept all risks of his/her participation. I understand that this document is intended to be as broad and inclusive as permitted by the laws of the State of Colorado, and agree that if any portion of this Agreement is ruled invalid by a court of law, the remaining provisions will continue in full legal force and effect.
