

RESOLUTION OF THE TOWN OF LA JARA

Resolution No. 1972-1

RESOLUTION AFFIXING GENERAL ELECTION, APPOINTING JUDGES AND CLERKS THEREFOR AND FIXING THE DATE THEREFOR

Be it resolved by the Board of Trustees of the Town of La Jara as follows:

1. That the general elections for the office of Mayor and six (6) members to be elected to the Board of Trustees to the Town of La Jara shall be held on April 4, 1972.
2. That the polling place for such election shall be the Town Hall, formerly known as the Depot Building, as such is located in the Town of La Jara, County of Conejos with the polling to commence at the hour of 7:00 o'clock A.M. in the forenoon and to continue until the hour of 7:00 o'clock P.M. in the afternoon.
3. That the vacancies to be filled at such election shall be the office of Mayor for a term of two (2) years and the office for six (6) trustees for the Town of La Jara, which such six (6) trustees shall be elected from the qualified electors within the corporate limits of the Town of La Jara.
4. That the Clerk shall give notice in writing as provided by rule and shall cause to be issued a list of candidates as nominated in the manner as required by law.
5. That the registration for the municipal election shall be in accordance with the registration as on file with the Clerk and Recorder in Conejos County, Colorado, as such defines the voters within the corporate limits.
