

RESOLUTION NO. 1975-2

A RESOLUTION TO APPROPRIATE SUMS OF MONEY TO THE VARIOUS FUNDS AND SPENDING AGENCIES, IN THE AMOUNTS AND FOR THE PURPOSES AS SET FORTH BELOW, FOR THE TOWN OF LA JARA, COLORADO, FOR THE 1975 BUDGET YEAR.

WHEREAS, the Board of Trustees has adopted the annual budget in accordance with the Local Government Budget Law, on the 14th day of January, 1975, and;

WHEREAS, the Board of Trustees has made provision therein for revenues in an amount equal to or greater than the total proposed expenditures as set forth in said budget, and;

WHEREAS, it is not only required by law, but also necessary to appropriate the revenues provided in the budget to and for the purposes described below, so as not to impair the operation of the Town of La Jara.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF LA JARA, COLORADO:

Section 1. That the following sums are hereby appropriated from the revenues of each fund, to each fund, for the purposes stated:

RESOLUTION NO. 1975-3

A RESOLUTION TO ENTER INTO CONTRACT WITH THE SAN LUIS VALLEY COUNCIL OF GOVERNMENTS FOR THE PURPOSE OF COLLECTING AND TESTING OF SEWAGE DISCHARGE SAMPLES PURSUANT TO THE GUIDELINES AND REGULATIONS PRESCRIBED BY THE COLORADO DEPARTMENT OF HEALTH AS ENFORCEMENT AGENCY FOR THE UNITED STATES ENVIROMENTAL PROTECTION AGENCY AND TO AUTHORIZE THE LA JARA TOWN CLERK TO SIGN SAID CONTRACT FOR AND IN BEHALF OF THE TOWN OF LA JARA, COLORADO.

WHEREAS, in the opinion of the Board of Trustees of the Town of La Jara it is necessary and desireable to participate with the San Luis Valley Council of Governments for the purpose of collecting and testing of sewage discharge samples pursuant to the guidelines and regulations prescribed by the Colorado Department of Health as enforcement agency for the United States Enviromental Protection Agency, and;

WHEREAS, the Board of Trustees find it necessary to authorize a responsible person as agent for the town, to sign said contract for and in behalf of the Town of La Jara, Colorado.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF LA JARA, COLORADO:

Section 1. That the Board of Trustees of the Town of La Jara has appointed, and by this resolution, appoints the La Jara Town Clerk to sign said contract giving unto said Town Clerk full power and authority so to do, and the Board of Trustees does hereby ratify and confirm the signing of said contract lawfully done pursuant to the authority hereby confered upon him.
