

RESOLUTION No. 1977-1

A RESOLUTION PROVIDING FOR THE WRITTEN APPOINTMENT OF POLICE OFFICERS FOR THE TOWN OF LA JARA, COLORADO.

WHEREAS, Colo. Rev. Stat. 29-5-101 (1973) provides that no police officer shall be appointed "without having first received his appointment in writing from the lawfully constituted authorities of the State," and

WHEREAS, there has been a finding by the Board of Trustees of the Town of La Jara that the police officers presently employed by the Town are bona fide residents of the State of Colorado as required by the aforesaid statute.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF LA JARA, COLORADO:

Section 1. That the Mayor of the Town of La Jara appoint and employ, and by this Resolution is hereby authorized and ordered to appoint and employ, Joe B. Martinez of Romeo, Colorado, as a duly commissioned police officer of the Town of La Jara.

Section 2. That to the extent permitted by law, this Resolution and the writtin appointment of said police officer as herein provided be given retroactive effect to the date of commencement of employment for the aforesaid police officer.
