RESOLUTION OF THE BOARD OF TRUSTEES OF THE  
TOWN OF LA JARA AUTHORIZING OFFICERS TO  
MAKE DEPOSITS AND WITHDRAWALS

I HEREBY CERTIFY that I am the Town Clerk of the Town of La Jara, Colorado, a municipal corporation organized and existing under the laws of the State of Colorado.

I FURTHER CERTIFY that a meeting of the Board of Trustees of said Town was duly called and held at its office in the Town of La Jara and State of Colorado on the 8th day of November, 1977, that at said meeting a quorum was present and voting throughout, and that the following resolutions were duly adopted and are now in full force and effect.

RESOLVED that the First National Bank of La Jara, Colorado, a National Banking Corporation, be and it is hereby designated as a depository of all of the various funds of the Town of La Jara, Colorado, and that all of said funds be subject to withdrawal upon checks, notes, drafts, bills of exchange, acceptances, undertakings or other orders for the payment of money when signed by any two of the following: Mayor Ben Gallegos, Mayor Pro-tem Doug Motz, Trustee Eloy Perea, and Town Clerk Atilano S. Mondragon.

RESOLVED that above Bank is authorized to pay any such checks, notes, drafts, bills of exchange, acceptances, undertakings or other orders and also to receive the same for the credit of or in payment from the payee or any other holder without inquiry as to the circumstances of issue or the disposition of the proceeds thereof, even if drawn to the individual order of any signing officer or payable to said Bank or others for his account, or tendered in payment of his individual obligation.

RESOLVED that said Bank be promptly notified in writing by the Town Clerk or any other officer of this municipal corporation of any change in these resolutions and that until it has actually received such notice in writing said Bank is authorized to act in pursuance of these resolutions.



RESOLUTION OF THE BOARD OF TRUSTEES OF THE

HAVE CERTAIN FUNDS WITHDRAWN

RESOLVED that the First National Bank of La Jara, Colorado, a National Banking Corporation, be and it is hereby designated as a depository of all of the various funds of the Town of La Jara, Colorado, and that all of said funds be subject to withdrawal upon checks, notes, drafts, bills of exchange, acceptances, orders or other orders for the payment of money when signed by any two of the following: Mayor Ben Gallegos, Mayor Pro-Tem Douglas Martin, Douglas Kots, and Town Clerk William S. Monaghan.

RESOLVED that said Bank is authorized to pay any such checks, notes, drafts, bills of exchange, acceptances, orderings or other orders and also to receive the same for the credit of or in payment from the payee or any other holder without inquiry as to the circumstances of issue or the disposition of the proceeds thereof even if drawn to the individual order of any signing officer or payable to said Bank or others for his account, or referred in payment of his individual obligation.

RESOLVED that said Bank be promptly notified in writing by the Town Clerk or any other officer of this municipal corporation of any change in these resolutions and that until it has actually received such notice in writing said Bank is authorized to act in pursuance of these resolutions.
