

RESOLUTION NO. 390

A RESOLUTION OF THE BOARD OF TRUSTEES FOR THE TOWN OF BAYFIELD, COLORADO CANCELING THE APRIL 3, 2018 ELECTION AND DECLARING CANDIDATES ELECTED TO OFFICE.

WHEREAS, the only matter before the voters at the April 3, 2018 regular election is the election of four Trustees to Office; and

WHEREAS, there were four vacant Trustee seats and four nomination petitions received by the legal filing deadline of January 22, 2018; and

WHEREAS, there were no affidavits of intent filed for write-in candidates by the legal filing deadline of January 29, 2018; and

WHEREAS, in accordance with C.R.S. Section 31-10-507, if at the close of business on the sixty fourth (64th) day before the election there are not more candidates than offices to be filled at such election, including candidates filing affidavits of intent as write-in candidates, the Town Clerk, if instructed by resolution of the governing body, shall cancel the election and by resolution declare the candidates elected; and.

WHEREAS, in accordance with Section 2-62(a) of the Bayfield Municipal Code, if at the close of business on the nineteenth (19th) day before the election there are not more candidates than offices to be filled at such election, including candidates filing affidavits of intent as write-in candidates, the Town Clerk, if instructed by resolution of the governing body, shall cancel the election and by resolution declare the candidates elected.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF BAYFIELD, COLORADO AS FOLLOWS:

Section 1: The above recitals are incorporated into this Resolution as findings of fact by the Town Board.

Section 2: The Town Clerk is hereby directed to cancel the April 3, 2018 election, and provide public notice of the election cancellation and the election of candidates as provided in C.R.S. Section 31-10-507 and Subsection 2-62 (b) of the Bayfield Municipal Code.

Section 2: Upon such cancellation the candidates for such office as follows, are hereby declared elected to four year terms, effective April 3, 2018.

Trustee – Brenna Morlan
Trustee – Ashleigh Tarkington
Trustee – Kelly Polites

Section 3: Upon such cancellation the candidate for such office as follows, is hereby declared elected to a two year term, effective April 3, 2018.


Trustee – David Black
