All interested persons are invited to attend this public hearing and to submit comments to the Director for consideration concerning the proposed rules.

3. Oral comments may be provided at the hearing as follows:




- a. All persons wishing to provide oral comment must sign up to do so at the hearing, noting who they represent.

- c. At her discretion, the Hearing Officer may limit or extend the time of any speaker.
