

Dear Board of Trustees,

This is a letter of information about our Source Water Protection Program. The Colorado Rural Water Association is a nonprofit organization that provides technical services to small rural public water systems throughout Colorado. The goal of our Source Water Protection Program is to reduce or eliminate the potential risks to drinking water supplies through the development of Source Water Protection Plans and provide assistance to entities for the implementation of prevention measures. I am funded under a grant from the USDA to Colorado Rural Water Association to coordinate and facilitate the process of developing this plan; therefore there is no cost for this service to you.

Developing a Source Water Protection Plan involves organizing a Planning Team, delineating a protection area around your water source, identifying potential sources of contaminants, and developing management approaches to implement to protect the water source. The planning process takes from 4-6 months, with one meeting per month. I can help your community with organizing and facilitating the meetings, researching information, and writing the protection plan.

I am interested in helping you develop a Source Water Protection Plan for your public water system during 2013. The value of having a clean, high quality drinking water supply cannot be over emphasized. I can also sign you up for the \$5,000 grant from Colorado Department of Public Health and Environment that can be used for implementing this Plan.

I am available to provide a short presentation about our program to your Board of Trustees at your July 16, 2013 work session.
