Chairman James Zwetzig called the meeting to order and asked Morgan County Chief Deputy Clerk Randee Aleman to lead the meeting in the Pledge of Allegiance.

### Consideration of Approval - RIGHT OF WAY - 2017 PMT 12 - City of Fort Morgan

Morgan County Road Supervisor John Goodman presented to the Board for approval, a Right of Way Permit 2017 PMT 12, with City of Fort Morgan. Mr. Goodman stated this right of way permit is to trench across Saunders Street, beginning at a point north in the right of way Highway 34 trenching north 630 feet, ending at the City of Fort Morgan city limits of Saunders Road for the purpose of installing a water line. He stated the fees are attached in the amount of \$113.00 and the location has been inspected.

Commissioner Arndt made a motion to approve Right of Way Permit 2017 PMT 12 with City of Fort Morgan as outlined by Morgan County Road Supervisor John Goodman on the permit and authorized the Chair to sign. Chair Zwetzig seconded the motion and motion carried 2-0.

#### Consideration of Approval – FIREWORKS DISPLAY PERMIT – May 6, 2017 – J & M Displays, Inc.

Morgan County Administrative Services Manager Kristi Waite presented to the Board the application submitted by J & M Display, Inc. (Claire Skalinski) for a Fireworks Display Permit on May 6, 2017. Ms. Waite stated the necessary paperwork has been submitted and the Wiggins Rural Fire Department has approved this fireworks permit and this will be contingent upon any fire ban that may be in place at the time. Ms. Waite stated this display is for a wedding being held on this date for a community member.

Commissioner Arndt made a motion to approve the Fireworks Display Permit with the notation that if there should be any fire ban in place, the permit will not be authorized with the applicant being J & M Displays, Inc. (Claire Skalinski) as outlined by Morgan County Administrative Services Manager Kristi Waite and authorized the Chair to sign. Chair Zwetzig seconded the motion and motion carried 2-0.
