All Registrations shall be valid for one year from the date of issuance (Rule 2.10).
Registrations cannot be assigned or transferred to another business, individual or other entity (Rule 2.3)
No industrial hemp shall be included in more than one Registration simultaneously (Rule 2.4)
No Land Area may be included in more than one registration at the same time (Rule 2.15)
A Registrant must have the legal right to cultivate Industrial Hemp on the Registered Land Area AND the legal authority to grant the Department access for inspection and sampling (Rule 2.1.8).

. APPLICATION CHECKLIST

Review this checklist prior to submitting your application. An accurate and complete application helps avoid delays in processing.

Corporate Registration: If registering as a business it must be *in good standing* with the Colorado Secretary of State. The person signing the application must be a registered agent or an officer of the corporation.

Sole Proprietorship: If you are registering as an individual (sole proprietorship) a citizenship immigration verification form (available on CDA website) and a copy of your driver's license must be included.

Additional Contacts Legal Representative: Now is the best time to identify all additional individuals who are authorized to communicate with the CDA on your behalf.

MAP: You must create a map of the Registered Land Area that contains all of the requirements listed below. Google Earth Pro tutorial links are available at the CDA website. To create your map, it is suggested you go to Google Earth Pro and include all of the following:

- Pin the center of the registered grow area (see pin at the top of the google earth pro screen).
- Determine the latitude and longitude in decimal degrees. Make sure this information is stated on the map.
- Outline the entire Registered Land Area (all land you want to register). Use the ruler/polygon at the top) or outline with a marker. Boundaries of the Registered Land Area must be easily identifiable and delineated. This is for your protection. Lack of clear boundaries opens you up for interpretation by outside entities.
- Write on the map the specific number of acres and/or square feet.
- Print the map and SIGN the map. E-mailed maps must be Pdf format.
- Be sure to fill in the boxes on the application asking for latitude and longitude in decimal degrees.

Pre-Planting Report: You do not need to submit a Pre-Planting Report if you provide accurate information about the Variety(s) and General Grow Site(s) in the application. If you do not provide this information now, check "NO" on page 6 of 8. **NOTE: A Pre-Planting Report must be provided to the CDA prior to planting.** This form can be downloaded at www.colorado.gov/agmain. (Go to Plants/drop down and click on Industrial Hemp).

Industrial Hemp Plant Declaration for Inclusion: If you have plant material from your previous Industrial Hemp Registration OR volunteer plants you must complete an Industrial Hemp Plant Declaration for Inclusion (download at www.colorado.gov/agmain; go to Plants; drop down and click on Industrial Hemp).

IMPORTANT INFORMATION FOR INDUSTRIAL HEMP REGISTRANTS

Industrial Hemp Registrant Responsibilities and Reporting Schedule

- ***Upon accurately and completely filling out your application***, allow up to 30 days for application review and approval process. Any incomplete applications will not be processed and application fees will not be refunded.
- ***Prior to planting*** you must verify that the Registrant has reasonable grounds to believe that the crop the Registrant will plant is of a type and variety of Cannabis that will produce a Delta-9THC concentration of no more than 0.3% on a dry weight basis, describe the Cannabis varieties to be planted, include a map showing where the varieties will be planted and state the intended use of the industrial hemp grown (***Pre-Planting Report*** that requires this verification can be downloaded from the CDA website under Plants/drop down to Industrial Hemp).
- ***You must have your industrial hemp registration certificate prior to planning.***
- ***If a Registrant intends to include plants in the Registration*** that were included under a previous registration certificate, the plant material must be declared on an Industrial Hemp Plant Declaration for Inclusion Form that accompanies the new application (***Industrial Hemp Plant Declaration for Inclusion Form*** can be downloaded from the CDA website under Plants/drop down to Industrial Hemp).
- ***Within 10 days after Planting any Cannabis And/OR 10 Days after Emergence of Any Volunteer Cannabis Plants*** in a Registered Land Area that the Registrant chooses to cultivate and not destroy a Registrant is required to submit a Planting Report and provide a list of varieties, location(s), maps, and actual acreage/square footage of each variety. (***Planting Report*** can be downloaded from the CDA website under Plants/drop down to Industrial Hemp).
- ***Individuals who are not authorized to communicate with the CDA (not specifically identified in the application) will be unable to communicate with the CDA.*** Any changes to contact information including address, phone, and email must be provided to the CDA within 10 days of change.
- ***Please adjust your filter or spam.*** Registrants should be aware that communications from the CDA will occur via written and/or email correspondence so please adjust your email filter and spam settings accordingly.
- ***Registrants that participate in voluntary private testing*** are not exempt from being selected for sampling from the CDA.
- ***30 days prior to harvest*** Registrants shall submit a Hemp Harvest Notification Form that reports anticipated harvest date, location of each variety, and documentation of purchase agreement with an in-state hemp processor or, if no agreement established, a statement of intended end use (***Harvest Report*** can be downloaded at the CDA website under Plants/drop down to Industrial Hemp).
- If your harvest is immature cuttings/clones, then document Immature Plants on your Harvest Report.
- ***Within 10 days after notice of selection for sampling*** Registrant must contact the CDA to arrange and schedule inspection.
- ***When selected for sampling within 30 days of the date of invoice***, all Registrants must reimburse the CDA for inspection and sampling fees, drive time, mileage, and laboratory analysis.

Colorado's Industrial Hemp Program

The Colorado Department of Agriculture's regulatory role with Industrial Hemp is limited to registration of growers and inspection of crop. The state of Colorado has no jurisdiction over many other factors that producers are faced with. While Colorado legalized the production of Industrial Hemp (*Cannabis spp*), growing it is still considered illegal under Federal Law. The following issues may cause concern for those interested in growing this crop in Colorado.

- **Seed Procurement / Seed Quality** - Seed that exists in Colorado may be variable and have unknown THC levels. Random sampling of hemp fields will be conducted. Plant samples testing at levels higher than 0.3% THC will be in violation of the Colorado Industrial Hemp Registration and Production Act. Currently CDA approved certified seed does not exist.
- **Seed vs. Grain** - Seed represents a product that will germinate, grow or reproduce. Grain is seed that has been treated so that it will not germinate, grow or reproduce and will be used for processing or consumption. Grain may be legally imported into the U.S under current laws.
- **Pesticides** - There are a limited number of pesticides (herbicides, insecticides, fungicides, etc.) currently registered for use on *Cannabis spp*. (Industrial Hemp and marijuana) due to the predominant federal nature of pesticide regulation. The CDA has a list of pesticides that could be used on *Cannabis spp*. and not constitute a violation of pesticide labeling or other federal and state pesticide laws and regulations. This list is available on the CDA website.
- **Federal Farm Programs** such as crop insurance, farm loans and conservation reserve may be jeopardized if industrial hemp is planted; these programs are managed by USDA a Federal Agency. Contact a lawyer for legal advice or the agency responsible for further information.
- **Banking** – Banks including state-chartered banks may be reluctant to provide services to *Cannabis* growers for fear of being prosecuted for federal laws and regulations violations.
- **Processing** - Colorado's industrial hemp rules state that industrial hemp producers must provide documentation of in state processing as part of registration. It is unknown at this time how many processing facilities will be available in Colorado at time of harvest.
- **Zoning** – check with local, city and county conveyances, codes and zoning requirements for industrial hemp prior to planting.
- **Shipping** – Shipping Industrial Hemp outside of Colorado is beyond the jurisdiction of the CDA. This remains federal jurisdiction and open to deliberation with federal officials.
- **Selling** – Selling material outside of the regulated program exposes the registrant and the buyer to legal scrutiny from outside entities.

Industrial Hemp Registration and Inspection Program

Quick Facts

- Amendment 64 to the Colorado Constitution directed the General Assembly to enact legislation governing the cultivation, processing, and sale of industrial hemp. Legislation adopted in 2013 delegated the responsibility for establishing registration and inspection regulations pertaining to cultivation to the Colorado Department of Agriculture.
- New and revised rules for the Industrial Hemp Program are effective as of March 30, 2016.
- Industrial Hemp means a plant of the genus *Cannabis* and any part of the plant, whether growing or not, containing a delta-9 tetrahydrocannabinol (THC) concentration of no more than three-tenths of one percent (0.3%) on a dry weight basis. Material in excess of 0.3% THC is by definition marijuana.
- Commercial registrants are not limited in size of acreage and will be charged an application fee of \$500 plus \$5/acre (outdoor) or \$0.33/1000 sq ft (indoor).
- When registering, applicants must provide:
 - contact information
 - maps that include GPS location of registered land area, growing locations, and varieties planted.
- CDA will select up to 100% of registrants each year for field sampling and verification of 0.3% or less THC content.
- Costs of field sampling and lab testing incurred by the Department will be passed on to the registrant.
 - Fees for field sampling are currently \$35/hour and will include drive time and sampling time, a \$150/per sample charge, and mileage at 0.25/mile.
 - All regulatory samples will be processed by the CDA Biochemistry Lab, following established protocol.
- If an Industrial Hemp sample tests higher than 0.3% but less than 1% THC content the registrant shall not be subject to penalty if the crop is destroyed or utilized on site in a manner approved of and verified by the Commissioner. Sample test results for Industrial Hemp registrations that are greater than 0.3% THC on a dry weight basis may be provided to the appropriate law enforcement agencies.
- Anyone selling seed that they grow or package in Colorado (regardless of Genus and species) must register as a seed labeler or farmer seed labeler with the Colorado Department of Agriculture.
