INSTRUCTIONS AND INFORMATION

APPLICATION: Application must be made by each person, firm, corporation, or association in business as a nurseryman, collector, landscape contractor, and/or sod producer selling nursery stock. Each branch, sales yard, store, or sales location is considered a separate location and must be registered separately.

REGISTRATION FEES: Registration Fee is a charge of **\$90.00** for each applicant. **A re-applicant that was registered in the previous year that fails to re-apply by March 1st must pay an additional fee of \$90.00.**

REGISTRATION CARDS: Each applicant desiring one or more wallet size registration cards should indicate the number of cards requested in the proper space above. A fee of **\$5.00** will be charged for each card.
