**A RESOLUTION APPOINTING AN INTERIM MUNICIPAL JUDGE**

**WHEREAS**, the City is authorized by C.R.S. § 13-10-105 and Sections 2.12.010 and 2.40.040 of the Leadville Municipal Code to appoint a Municipal Judge to preside over the Leadville Municipal Court; and

**WHEREAS**, the Municipal Code at Section 2.40.040 sets the term of the Municipal Judge at two (2) years and requires that the Municipal Judge, at all times during the term of office, be currently licensed to practice law in the State of Colorado; and

**WHEREAS**, Neil V. Reynolds is a licensed attorney in the State of Colorado and has previously served as the Municipal Judge for the Leadville Municipal Court; and

**WHEREAS**, the most recent term of the Municipal Judge expired on February 1, 2020; and

**WHEREAS**, pursuant to Article 12, § 1 of the Colorado Constitution, upon the expiration of the term of an appointive office, such as that of the Municipal Judge, the incumbent judge holds over in that office until a successor is duly appointed; and

**WHEREAS**, the City desires to appoint its Municipal Judge following a formal request for proposals (“RFP”) process; and

**WHEREAS**, to ensure the continued operations of the Leadville Municipal Court pending the outcome of the RFP process, the City Council desires to appoint Neil Reynolds on an interim basis such that he maintains his holdover status until a successor is appointed; and

**WHEREAS**, the interim appointment shall commence on February 4, 2020 and shall expire upon the appointment of a Municipal Judge according to the results of the City’s RFP process.

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CENTRAL, COLORADO, THAT:**

**Section 1. Interim Appointment.** The City Council hereby appoints Neil V. Reynolds as the Leadville Municipal Judge on an interim basis such that he continues in his holdover status effective February 4, 2020.

**Section 2. Termination of Interim Appointment.** This interim appointment shall expire upon the appointment of a Municipal Judge following the completion of a formal request for proposals process for the appointive office of Municipal Judge.

**Section 3. Effective Date.** This Resolution shall take effect upon its approval by the City Council.
