It is understood by the applicant that this permit when issued is valid only on those roads and highways under the jurisdiction of the Board of County Commissioners of Washington County.

If the requested permit is granted, the undersigned agrees:

1. To take every precaution to protect the highways and the traffic from damage or injury, using pilot cars or flagmen to warn the traveling public on all blind curves, both vertical and horizontal.
2. In case of over-width of load, the same is to be placed on the vehicle with the overhangs as far to the right as possible, and in any event the material is to be loaded so as to present the minimum hazard to traffic.
3. Transport of equipment is only allowed between DAYLIGHT and DARK. All traffic loads must be removed from highways and county roads except between DAYLIGHT and DARK.
4. To be financially responsible and to make prompt payment for any damage caused to the traffic or highway and county roads or bridges by the transportation of this load in excess limitations prescribed by statute. Further to be financially responsible for any damage to utilities which adjoin or cross the county road rights of way including electricity, telephone and oil and gas pipelines.
5. That the operators of the vehicles are duly licensed according to statute.
6. To operate the vehicle or vehicles at all times in accordance with any and all provisions of law, except as exempted herein with regard to motor vehicles and the operation thereof.
7. Except when a permit is requested and granted for overweight, the undersigned applicant specifically states that his load is legal weight, and the same cannot be loaded to conform to the statute.

THIS PERMIT IS NOT GOOD SATURDAYS, SUNDAYS OR HOLIDAYS

This application when signed by the County Board of Commissioners of Washington County, Colorado or their authorized agent, in the space below becomes the requested permit subject to the conditions with the understanding that no liability is assumed by the County of Washington by reason of it's issuance, in regard to conditions of roads or capacity of culverts and bridges, and the applicant is charged to make necessary examination and inspection as to the adequacy of roads and bridges to care for the traffic movement. In case of an emergency, The Board of County Commissioners of Washington County or their authorized agent has authority to suspend this permit until emergency conditions have passed.
