## OFFICIAL ID OPTIONS

### 840 Tags \*\*

A 'button' Radio Frequency Identification Device (RFID) or 'bangle' tag or a combination RFID/bangle, this tag has a unique 15-digit number that begins with 840. 840 tags can only be applied to cattle born in the



### Orange Brucellosis or 'Bangs' Tags

This orange metal tag must be applied by accredited veterinarians when they vaccinate calves for brucellosis, also called Bangs.

**Where to Buy:** Rocky Mountain Regional Animal Health Lab (RMRAHL) at 303.477.0049 or other approved tag suppliers.



### Brucellosis RFID or EID Tags

This orange RFID 840 tag must be applied by an accredited veterinarian when calves are brucellosis (or Bangs) vaccinated. Because it is an 840 tag, it also can serve as "one tag fits all" for producers.

### Silver or "Brite" or NUES Metal Tags

Historically used by accredited veterinarians for disease testing and programs. USDA now gives states and tribes the option, and flexibility, to allow producers to apply the National Uniform Eartagging System (NUES) tags themselves. Producers interested in obtaining NUES eartags must contact their State or Tribe animal health official.
