The following dates are available for hearings that have been continued by order pursuant to Section 8-43-209(1) or (2), C.R.S. . These hearing dates may also be selected by parties who have agreed to waive the 80-day minimum requirement set forth in Section 8-43-211(2), C.R.S.

These dates may NOT be selected for hearings that have already commenced before a specific judge.

The parties must call the docketing staff to schedule a full or half day hearing before a specific judge.

For all initial settings and re-scheduled hearings, the parties are responsible for ensuring accurate calculation of the setting deadlines set forth by the Workers' Compensation Act or by the order of a judge.
