**EMERGENCY SPECIAL MEETING MINUTES
SUNDAY JUNE 3, 2018 @ 5:00 P.M.**

Call to Order and Roll Call @ 5:05 p.m.

1. Jim Donovan – San Juan County Emergency Manager – 416 Fire Briefing

Emergency Manager, Jim Donovan, gave a full briefing of the fire activity, and then introduced the Incident Management Team. Each team member also introduced themselves and gave a description of their roles. Mr. Donovan gave updates on the road closure, the train activities, the evacuee registration and shelter, and the reunification system in place. He then discussed plans for the next 72 hours. DeAnne Gallegos, designated PIO, gave a brief of the current information channels and updated the Boards on the most current multi-agency information.

2. Ordinance 2018-05 An Emergency Ordinance establishing a Phase II Municipal Fire Ban and providing provisions for the initiation of Stage II fire restrictions.

Discussion: The trustees agreed to remove section 2(h) – Possessing or using a motor vehicle off established roads, motorized trails or established parking areas, except when parking in an area devoid of vegetation within 10 feet of the vehicle. Trustee Wegert addressed the concern of spark throwing equipment, i.e. grinders, and use of such equipment was included in the fire restrictions in the ordinance. The Sheriff clarified what the penalty is for violation of any of the fire restrictions and that language was also included in the ordinance.

Mayor Pro Tem Lashley moved and Trustee Wegert seconded to approve Ordinance 2018-05 An Emergency Ordinance establishing a Phase II Municipal Fire Ban and providing provisions for the initiation of Stage II Fire Restrictions, with the afore mentioned amendments. The motion passed unanimously with a roll call vote.

3. San Juan County Resolution 2018-03 Stage II Fire Restrictions

The Board of County Commissioners approved and adopted Resolution 2018-03.
